## Presbytery of Coastal Carolina Stated Clerk's Report May 16, 2019

**Presbytery Meeting Review** - Evaluations reflected that there was great energy and excitement surrounding the presbytery meeting. The evaluation format was changed and enabled individuals to reflect upon the work done at a presbytery meeting that energized respondents. Evaluations are available for those that would like to review them. In the future we may consider a different presentation for Bills and Overtures. Laurinburg PC did a wonderful job hosting the presbytery meeting. I cannot thank the staff enough for their support and encouragement preparing, running, and cleaning up after the meeting.

**Correspondence** - none to be shared.

**AC updates** - three Administrative Commissions were recently trained to address concerns raised by the following sessions: Pike Rocky Point, Teachey, and Pearsall. The AC for Faison Memorial is receiving proposal for selling the property.

**Hurricane Recovery Grant updates** - Several Long Term Recovery Groups operating in the bounds of the presbytery have been endorsed and received unrestricted grants from the synod. Sixteen congregations have applied for an extension of the PDA church damage grant (\$150,000 available). Carteret County LTRG is the only group that has applied for additional grant funds made available to the presbytery by PDA (\$350,000 available).

**Presbytery Staff Retreat** - PDA is working with Nancy Gladden to organize a staff retreat. PDA funds these retreats to provide respite care for mid-council offices that have been impacted by natural or human disasters. It is my hope that this event will be a time for rest, relaxation, and getting to know each other better.

# Minimum terms of call assume a normal, full-time work week of 40 hours, with 2 days off each week.<sup>6</sup>

- <sup>1</sup> Effective salary includes cash salary, housing allowance, and the value of the use of a manse, if provided.
  - ° Effective salary also includes any optional Board of Pensions benefits (such as dental insurance), 403(b)(9) salary reduction contributions, medical reimbursement plans, annual bonus, and other compensation.
  - ° See the Board of Pensions "total effective salary calculator" at www. pensions.org.
- <sup>2</sup>Board of Pension required dues include medical coverage (25% of effective salary, based on a minimum salary of \$44,000); pension (11%), and death and disability coverage (1%)
- <sup>3</sup>One-half of SECA tax is 7.65% of salary and housing
- <sup>4</sup>Expenses reimbursement: an amount set aside for mileage, continuing education, and other professional expenses, available <u>only</u> through monthly submission of mileage records and receipts. At the end of the year, unused funds remain in the church account they are not part of the minister's salary.
  - ° Mileage should be reimbursed at the IRS rate. Continuing education (including details of content and cost) must receive prior approval of the Session.
- <sup>5</sup> Additional funds provide choices appropriate to each minister's situation and needs, such as medical reimbursement, deferred compensation, manse equity, additional professional expenses, etc. Decisions about how to use these funds must be made before congregational approval of terms of call for the new year and spelled out in the minutes of the congregation.
  - **NOTE:** By allocating "Additional Funds" to Effective Salary items, premiums for BOP and SECA may increase. Take those increases into account when allocating the additional funds. Changes may also impact the minister's tax burden.
- <sup>6</sup> Work schedule: Since a minister's actual schedule is unpredictable, work hours often vary week to week. Even on days off, the minister is usually still "on call." Therefore, the Session and the minister must exercise flexibility, balancing work and rest to avoid pastoral burnout.

## **Important Notes:**

1. The division of funds between Professional Expenses and Continuing Education should be determined by the session in consultation with the pastor. The division of funds can vary from year to year.

- Accountable Reimbursable Expenses are usual, customary and reasonable expenses incurred in support of the ministry provided to the congregation by the pastor. They do not include commuting from home to church/office. Expenses are reimbursed upon the submission of appropriate receipts or mileage logs and should not be paid in regular monthly installments. If Accountable Expenses are paid in monthly installments then they must be counted as income and listed on the pastor's W-2 form. Pension, Disability, and Medical Dues would also have to be paid on them. It is up to the pastors to monitor their use of Accountable Expense funds so as not to run over by the end of the year.
  - Any unused funds revert to the church treasury at the end of the year. Unexpended budgeted funds for Accountable Reimbursable Expenses are **not** available to a pastor as compensation.
- Since Continuing Education funds are provided by the church in order to equip the pastor to be a more effective leader in the congregation, it is the responsibility of the pastor to consult with the session about the content, location, and cost of any continuing education before taking time off or incurring costs. The expenses will be reimbursed (within the limits of the agreement) upon presentation of receipts. Accrued Continuing Education time and money are forfeited upon dissolution of the pastoral relationship. Unexpended Continuing Education money are not available to a pastor as compensation.
- 2. For negotiations for service **less than full-time**, a normal (full time) work week is considered as 40 hours.
- 3. Other benefits (part of minimum terms of call):
  - a. Vacation of 4 weeks including 4 Sundays.
  - b. Study Leave of 2 weeks including 2 Sundays. The purpose of Study Leave will be planned in consultation with the Session.
  - c. Holidays as established by Presbytery policy.
  - d. Full usual, customary, & reasonable cost of moving to the field by a licensed carrier.
  - e. FAMILY LEAVE is recommended.

#### EITHER

A. FAMILY LEAVE is a mutual agreement between the Session and Pastor for the good and welfare of the whole of God's holy people. A Covenant of Care and Compassion is a formal opportunity to express agreement in family leave policies. Guidelines for A Declaration of Family Leave Policy and A Covenant for Care and Compassion are available at the Presbytery Office.

OR

- B. FAMILY LEAVE is time released for medical care and treatment.
  - <u>Sick Leave</u> shall accumulate at least 1 ¼ days each month to 90 days total. Sick Leave of 5 days shall be accrued to newly installed pastors. When sick leave taken exceeds 5 days in a 6-month period, a church may require a statement from the attending physician.
  - <u>Maternity/Paternity Leave</u> 4 weeks with payment of salary and benefits excluding reimbursable expenses. An additional two (2) weeks may be granted from accumulated sick leave if needed.
  - Adoptive Leave 4 weeks with payment of salary and benefits excluding reimbursable expenses.

# Full Commission on Ministry Proposed Process for Becoming a Temporary Member of the Presbytery of Coastal Carolina First Reading – June Gatherings, 2019

The Commission on Ministry has agreed to a process that, we hope, will make it easier and more welcoming for ministers of other denominations to serve our churches as temporary members of the Presbytery of Coastal Carolina. (Fulfilling requirements in the *Book of Order* in G-2.0506)

(The process for transferring <u>full</u> membership into the Presbyterian Church (USA) is laid out in the *Book of Order* G-2.0505 which basically requires any minister seeking full membership in the Presbyterian Church (USA) to fulfill the same requirements that we demand of our own candidates for ordination. The list of these requirements is found at G-2.0607.)

Temporary members are those who continue to maintain their membership in another denomination but are also determined to be qualified to serve as a Temporary Member in the presbytery serving one (or more) of our churches. The Commission on Ministry will present to the Presbytery for Temporary Membership, subject to the 3/4 majority vote for exceptions to the usual practice, ministers who:

- 1. Are in good standing in their current denominations (i.e. no disciplinary charges have been filed),
- 2. Have an invitation to serve as a Temporary Member Pastor in one of the churches of the Presbytery of Coastal Carolina, after having served successfully as a Temporary Supply for a period of at least six months, Temporary Membership expires when the pastoral relationship ends.
- 3. Possess a M.Div. degree from a seminary or school of theology accredited by the Association of Theological Schools at the time of graduation.
- 4. Demonstrate the qualifications of character and scholarship we expect by having served as ordained ministers for at least 7 years in pastoral ministry in a congregation,
- 5. Participate in and pass course requirements for the Presbytery CRE training (or equivalent) in 1) Reformed Theology, 2) Reformed Worship and Sacraments, and 3) Presbyterian Polity. Successful fulfillment of these requirements is mandatory before the Presbytery will vote on granting temporary membership in the presbytery.
- 6. Answer all the questions in W-4.0404 (a-i) [constitutional questions for ordination/installation]

## Presbytery of Coastal Carolina Mission Cabinet Report to Communities June, 2019

#### **Action Items:**

Request approval for a \$4,000 loan to Mars Hill PC for replacement of their HVAC system. Terms of the loan are 5 years with 0% interest, and all Per Capita and Shared Mission will be paid to the Presbytery as a condition of the loan.

Note: They are applying to the Synod for a grant, and, if received, it will be used to offset the loan.

#### **Information:**

- The Mission Cabinet and SPOR are planning a joint retreat to engage in conversation about the role of presbytery and reflect upon Simon Sinek's "Start with Why".
- Minutes from the January 28, 2019 and the March 2, 2019 Presbytery meeting were approved
- COM will be instructed to re-engage Holly Grove and Harmony in conversation about dismissal.
- The Cabinet approved summer working hours for the office staff: Monday through Thursday, Friday closed, beginning Memorial Day and ending Labor Day
- The Vital Congregation Coaching Contract with George and Beverly Thompson runs through December, 2019 and will not be renewed.
- The Mission Cabinet approved the request of First Presbyterian Church, Sanford to host the October 3, 2020 Presbytery meeting.

## **Finance and Property Information**

## At the end of April 2019, expenses exceeded revenue by \$20,212

#### **Information Items:**

- 1. A \$1,000 grant from the Opportunity Fund was approved for Mars Hill PC to help with replacement of HVAC
- 2. Insurance Coverage: In light of damages from the recent storms, It is vitally important that churches assess their insurance coverage annually to insure that they are adequately covered, especially with Flood and Wind/Hail. This should be done at least six months prior to the expiration date of present policies. Insurance agents are the best sources for explanation of insurance coverage available, coverage possibly needed, and the cost.
- 3. Funds from the Capital Needs Fund were approved to underwrite an upgrade of the computer system to Microsoft 365, if needed.
- 4. Freedom East PC update. One item needs to be inspected and then the loan will be forgiven as a grant. Extensive modifications have been done to the church.

- 5. Update on Fuente de Agua Viva church building. The building they had the architect to draw plans for is too expensive, current estimates being \$500,000. They are currently meeting in the Teachey PC building on Saturdays and Sundays
- 6. Erwin Presbyterian Church has been dissolved and is being used by Manantial de Vida, the Hispanic fellowship who was meeting in Fuquay-Varina. Seems to be working out extremely well, although they have not yet remitted any funds to PCC to cover their operating expenses and insurance.
- 7. Dismissals Completed: Cypress, Galatia, Grove-Dunn, and Antioch-Jacksonville.
- 8. Amy's Chapel transfer of deed to Grace Anointed Chapel, Inc. has been completed.
- 9. Faison Memorial PC in Clinton, NC has been dissolved and has an AC in place. Rev. Lowry gave an update. There are currently three parties interested in buying the property, but no decision has been made yet.
- 10. An AC has been formed to help with the dissolution process of Pike-Rocky Point PC.
- 11. An AC has been formed to help with the dissolution of Pearsall Memorial PC in Wilmington, NC. The deed is in the process of being transferred to PCC, and we will be picking up their insurance.
- 12. The historical Brown Marsh PC deed is being transferred to Clarkton PC. Should be completed within the month.
- 13. Synod and PDA Grants are being processed as we receive the applications.
  - a. \$100,000 (\$5,000 maximum per applicant) in Synod grants available. Long-term recovery groups in Carteret, Duplin, and Cumberland counties have been given grants in the amount of \$5,000 each.
  - b. \$150,000 in PDA church structure repair grants for Florence recovery are being requested for the 16 churches in the Presbytery from which applications were received. These include New Hope, Grace, Cape Fear-Wil, First-Morehead City, First-Jacksonville, Black River, Bethany-Wil, Bethany-Lumberton, Shallotte, Highland, Church of the Covenant, Wallace, St. Pauls, Hallsville, Woodburn, Oak Grove. The committee was charged with recommending the amounts for each church, and after much discussion, decided upon a formula which they considered fair for each applicant. Rev. Lowry will forward to PDA for their approval.
  - c. \$350,000 in PDA grants are available: Carteret County long term recovery group has received a grant for \$74,125 to hire a director.




