Independent Auditor's Report

Board of Directors The Presbytery of Coastal Carolina, Inc. Elizabethtown, North Carolina

We have audited the accompanying financial statements of The Presbytery of Coastal Carolina, Inc. (a nonprofit organization), which comprise the statement of assets, liabilities and net assets-modified cash basis as of December 31, 2018, and the related statement of support, revenue and expenses-modified cash basis for the year then ended, and the related notes to the financial statements.

Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the modified cash basis of accounting as described in Note 1; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Auditor's Responsibility

Our responsibility is to express an opinion on these financial statements based on our audit. We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free of material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. Accordingly, we express no such opinion. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluating the overall presentation of the financial statements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Opinion

In our opinion, the financial statements referred to above present fairly, in all material respects, the assets, liabilities and net assets of The Presbytery of Coastal Carolina, Inc. as of December 31, 2018, and its support, revenue and expenses for the year then ended in accordance with the modified cash basis of accounting as described in Note 1.

We draw attention to Note 1 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is the basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

Our June 15, 2019 Gathering meeting at the Southport Presbyterian Church was a great success. Our theme revolved around Christian Formation and featured our keynote speaker, Dr. Joan Gray, author of "Sailboat Church" and "Spiritual Leadership for Church Officers." Throughout the day there were workshops in many different disciplines: music, worship, small group ministry, personal faith journey, church finances, spiritual leadership, photography, intergenerational recreation, and biblical storytelling. Thanks to all that served as workshop leaders and to Southport for hosting us in their beautiful new facilities.

East Community Pastor's Retreat

Our Keynote for our August 11-13, 2019 Pastor's Retreat was Dr. Richard Boyce- Academic Dean and Associate Professor of Preaching and Pastoral Leadership at Union Presbyterian Seminary in Charlotte. We had a great time of spiritual nurture, fellowship, and fun. We did a study of the Psalms and the Glory to God hymnbook with the theme: "From Mourning to Marching: Preaching and Singing the Songs of Faith."

Church Communications Workshop

On September 14, 2019 at Sneads Ferry PC two representatives from the Presbyterian Mission Agency out of Louisville did an informative workshop on communication planning, working with the media, social media, and Church websites. Every church in the Presbytery would have benefitted from this workshop so we will make materials available electronically.

The Presbytery of Coastal Carolina Inc. Budget and Finance Committee Report to Cabinet October 12, 2019

At the end of August 2019, expenses exceeded revenue by \$58,000. Please check with your church to see if their 2019 Per Capita and Shared Mission has been, or is being, paid.

Thank you for supporting Presbytery's programs and missions!! 2020 Pleage forms have been mailed to the church treasurers with a copy for the Clerk of Session.

Action Items:

1. Approve request from Church in the Pines for a loan in the amount of \$21,480 for new roofs on two buildings-the Ida Mill Chapel leased by Head Start and another building leased by Four County Electric. Terms are 0% interest for 60 months (\$358 monthly) and requirements that they pay Per Capita and Shared Mission annually. This is contingent upon their providing copies of both leases in addition to minutes of the session and congregational meetings giving approval for the loan.

Information Items:

- 2. Cabinet approved up to \$2,000 from the Gardner Edwards Educational Fund to cover expenses for a combined Cabinet/CSPOR seminar on "Start Your Why", by Simon Senneck, and led by Rev. Ken McFayden of Union Seminary.
- 3. Cabinet approved up to \$60,000 for replacement of roof on Pearsall Memorial PC in Wilmington, which was recently dissolved. Received a low bid of \$44,000 but will also have to do mold and mildew remediation, as well as structural assessment, since the roof was not tarped or repaired following Hurricanes Matthew and Florence and extensive damage occurred. Insurance is currently with Pearsall's insurer, but our insurer will not cover facilities until roof is repaired and other items addressed. Received three bids for repairs or new roof, and no one would repair it as the damage is too extensive. Funds will be repaid from sale of property, which has been put on the market for \$1.5 million initially. Funding sources would be: Capital Needs \$25,000, NCD \$25,000, and General Reserve Fund-Designated for Special Projects \$10,000. Deed has been transferred to Presbytery of Coastal Carolina. Attorney doing legal work is Scott Holmes in Wilmington, NC.
- 4. Freedom East PC update. All requested inspections have been completed, and their \$25,000 loan has been forgiven and converted to a grant. They were informed that they are expected to continue paying Per Capita and Shared Mission.
- 5. Approved \$250 from the Opportunity Fund to assist Monte de Olivos with a new glass front door which was broken during an attempted break-in. Estimates have been requested and must be received before payment is made.
- 6. Faison Memorial PC in Clinton, NC, has been dissolved and has an AC in place. Legal issues have prevented the sale of the property for \$15,000 from being completed. CRE Rob Price has been engaged as PCC legal counsel..
- An AC has been formed to help with the dissolution process of Pike-Rocky Point PC and Cemetery.
 The deed is being transferred to PCC, and it will be put on the market for \$525,000 initially. Attorney doing legal work is Scott Holmes in Wilmington, NC
- 8. The historical Brown Marsh PC deed has been transferred to Clarkton PC. Filed in Bladen County.
- 9. Assistance received for Hurricane Florence Recovery:
 - a. Synod for Long-Term Recovery Groups/Staff Retreat 26,470
 - b. PDA for church damages/Long-Term Recovery Groups/Staff Retreat 467,095
 - c. PDA Pastor Respite Grants (\$5,000 total for 10 Pastors)

Total funds received is \$552,915 and paid out \$548,000, assisting 52 churches and groups

10. Investment balance:

Full Commission on Ministry Proposed Process for Becoming a Temporary Member of the Presbytery of Coastal Carolina Voting at October 12, 2019 PCC meeting

The Commission on Ministry has agreed to a process that, we hope, will make it easier and more welcoming for ministers of other denominations to serve our churches as temporary members of the Presbytery of Coastal Carolina. (Fulfilling requirements in the *Book of Order* in G-2.0506)

(The process for transferring <u>full</u> membership into the Presbyterian Church (USA) is laid out in the *Book of Order* G-2.0505 which basically requires any minister seeking full membership in the Presbyterian Church (USA) to fulfill the same requirements that we demand of our own candidates for ordination. The list of these requirements is found at G-2.0607.)

Temporary members are those who continue to maintain their membership in another denomination but are also determined to be qualified to serve as a Temporary Member in the presbytery serving one (or more) of our churches. The Commission on Ministry will present to the Presbytery for Temporary Membership, subject to the 3/4 majority vote for exceptions to the usual practice, ministers who:

- 1. Are in good standing in their current denominations (i.e. no disciplinary charges have been filed),
- 2. Have an invitation to serve as a Temporary Member Pastor in one of the churches of the Presbytery of Coastal Carolina, after having served successfully as a Temporary Supply for a period of at least six months, Temporary Membership expires when the pastoral relationship ends.
- 3. Possess a M.Div. degree from a seminary or school of theology accredited by the Association of Theological Schools at the time of graduation.
- 4. Demonstrate the qualifications of character and scholarship we expect by having served as ordained ministers for at least 7 years in pastoral ministry in a congregation *or military chaplaincy*
- 5. Participate in and pass course requirements for the Presbytery CRE training (or equivalent) in 1) Reformed Theology, 2) Reformed Worship and Sacraments, and 3) Presbyterian Polity. Successful fulfillment of these requirements is mandatory before the Presbytery will vote on granting temporary membership in the presbytery.
- 6. Answer all the questions in W-4.0404 (a-i) [constitutional questions for ordination/installation]
- 7. Temporary Members may moderate only the session and congregational at the church where they are serving and will be assigned a COM member or teaching elder of the presbytery to mentor the Temporary Member during their initial session meetings.

TERMS OF DISMISSAL

of the Stanford Presbyterian Church from the Presbytery of Coastal Carolina, Presbyterian Church (USA) As of 8/1/2019

- 1. The congregation now known as Stanford Presbyterian Church will be dismissed, with its property, to another Reformed body—ECO: A Covenant Order of Evangelical Presbyterians—if 75% plus one or more of the active members of the congregation present during a consultative meeting called by the Presbytery in accordance with G-3.0301a concur with the Session's request for such dismissal as a confirmation of the congregation's will.
- 2. In recognition of our mutual history as laborers in the Kingdom, and in recognition of the Presbytery's fiduciary responsibility to the Presbyterian Church (USA), the following financial terms shall be paid by the congregation now known as Stanford Presbyterian Church to the Presbytery of Coastal Carolina on or before the effective date of dismissal:
 - a. **\$29,000** -- (4.8 NET acres). 4.8 acres @ \$6,041.67 per acre = \$29,000. The per-acre amount represents the average of the appraisal value of \$5,500 per acre, and the Duplin County tax value of \$6,583 per acre, and represents the value of the land ONLY, exclusive of any improvements. The appraisal was provided by the church and was conducted by Draughton Realty & Appraisal, Kenansville, NC;
 - b. **N/A** the total amount of unpaid per capita, not remitted by the congregation, but paid by the Presbytery;
 - c. \$ 60.00 the office expense (postage, envelopes, and labels) incurred by Presbytery during the discernment process. (To be determined)
 - d. \$ 336.84 the reimbursed travel expense (mileage) of the Presbytery Stated Clerk, Pastoral Team and Negotiating Team during the discernment process.

Items "a" through "d" will be due on or before the effective date of dismissal. The money received for the land will be used to maintain or re-establish a mission of the Presbyterian Church USA in that locale, for new church development elsewhere within the presbytery, or for other mission of the Presbytery as directed by the Presbytery.

- 3. The congregation so dismissed will use the new name **STANFORD CHURCH** to reflect the congregation's new affiliation with a Reformed denomination that is not the PCUSA.
- 4. The congregation so dismissed will sever all associations with the PCUSA, such as Presbyterian Women, Presbyterian Men, etc.
- 5. The following obligations should be met within 45 days and must be completed within 180 days (unless extended by mutual agreement between the congregation and the presbytery) of the vote by the Presbytery of Coastal Carolina to concur with the congregation's request for dismissal to another Reformed denomination, ECO: A Covenant Order of Evangelical Presbyterians.
 - a. Notification from the "receiving" Reformed denomination, (ECO: A Covenant Order of Evangelical Presbyterians) that the congregation now known as Stanford Presbyterian Church will be received pending dismissal by the Presbytery of Coastal Carolina.
 - b. The providing of the originals of all congregational records to the Presbytery of Coastal Carolina for transfer to the Presbyterian Historical Society. This includes, but is not limited

- to, minutes of the Session, minutes of any Boards of Deacons or Boards of Trustees, all membership rolls, and all registers. (G-3.0107). If it so desires, the departing congregation may make arrangements with the Presbyterian Historical Society to have copies made at the congregation's own expense.
- c. Satisfactory evidence of the updating of all deeds, property and liability insurance policies, articles of incorporation, by-laws and any other legal documents which have previously included the Presbytery of Coastal Carolina and/or the Presbyterian Church (USA).
- d. The church shall provide the Presbytery with satisfactory evidence that any loan(s) which the Presbytery guaranteed for the church has (have) been paid and satisfied.
- e. Release by the Presbytery of any claim or interest in the congregation's property, including release of Presbytery from any obligation for congregation's loans with any non-Presbyterian Church (USA) entity. However, a clause <u>shall</u> be placed into the deed of transfer of any property which a dismissed congregation is allowed to take into its new Reformed body that provides that if the congregation ceases to be a member of that denomination (or its successor) within a period of five (5) years that the presently held property would revert to the Presbytery of Coastal Carolina (or its successor).
- f. Mutual release of all claims that were or could have been made by the Presbytery against the congregation or by the congregation against the Presbytery. These documents will be drafted by the Presbytery of Coastal Carolina.
- g. Close out and submittal of the congregation's financial and membership reports to the Presbytery.
- h. Satisfactory evidence of communication with the Board of Pensions regarding cessation of payments at the time of dismissal as well as transfer of health insurance coverage for ministers and any staff enrolled in the Medical Benefits Plan of the PCUSA.
- 6. Within 30 days of the Presbytery's vote approving dismissal of the congregation or members thereof to another Reformed denomination, ECO: A Covenant Order of Evangelical Presbyterians, the Presbytery will prepare a letter to members of the congregation informing them of their option to be dismissed with the congregation or to remain in the Presbyterian Church (USA). The congregation will mail the letter to all active members promptly and will bear all costs associated with this mailing. The letter will direct that responses are returned to the Presbytery of Coastal Carolina. The Presbytery will then ensure that contact is made with those members wishing to remain in the PCUSA and that they are assisted in joining a new congregation of their choice, if there is no continuing PCUSA congregation.
- 7. The congregation now known as Stanford Presbyterian Church is encouraged to organize, and to invite representatives of the Presbytery to share in, a service of worship of Almighty God and thanksgiving for the witness and ministry of the departing congregation.
