SUPPLEMENTAL REPORT
Committee on Bills and Overtures
Presbytery of Coastal Carolina

Since the Presbytery's Commissioners' Handbook was distributed, we received from the Presbytery of New Hope requests for our concurrence with two overtures, one to the General Assembly, and the other calling for presbytery support and advocacy for raising the minimum wage in North Carolina. The Committee has reviewed both documents.

- I. The first New Hope overture asks the 224th (2020) General Assembly of the Presbyterian Church (USA) to instruct the Office of the General Assembly to update the video resource, "Who Are We Presbyterians," with an accompanying study guide. It also asks that OGA create a plan to update and finance this denominational video and study guide every 5 years.**

The resource was created in 2001, and was a tool for church school, officer training, new members' classes, confirmation classes, retreats, midweek gatherings, and more. While it was very useful initially, it is now 19 years old and needs to be updated for use in today's Church. Also, the original resource was in DVD format, and the new resource would be more useful in an online or other platform that could easily be shown to groups or viewed by individuals.

Furthermore, a plan for financing and updating such a resource would ensure that ministries of the church do not have to rely on out-of-date materials that fail to communicate accurately the life and witness of the Presbyterian Church. The Committee is recommending concurrence.

- II. The second New Hope overture originated in the Session of the Church of Reconciliation in Chapel Hill. It asks the Presbytery to support legislation in the next North Carolina General Assembly legislative session to increase the NC minimum wage incrementally to \$15 per hour by 2024; and to inform the governor and legislative leaders of that support; and to invite other NC presbyteries to concur and to take similar actions.**

The committee considered this request, reviewed the rationale for it, and analyzed the calculations offered in support for it. We do not oppose the goal of raising the minimum wage to ensure that hourly workers receive fair and livable pay. We know it has been more than 11 years since the minimum wage in North Carolina was raised. And we understand that this is a highly-charged political issue.

Yet we have concerns about this particular overture. One concern is that the numbers given to argue for the increase are flawed and do not compute. Another concern is that a specific minimum hourly wage is suggested without providing documentation or justification for that number. A third concern is that the rationale contains a political opinion which may or may not be correct, but which is most surely divisive.

RECOMMENDATIONS:

- 1. The Committee on Bills and Overtures recommends that the Presbytery of Coastal Carolina concur in the overture to the General Assembly from the Presbytery of New Hope concerning updating the resource, “Who Are We Presbyterians?”**

- 2. The Committee on Bills and Overtures recommends that the Presbytery of Coastal Carolina take no action at this time on the overture from New Hope Presbytery concerning legislation regarding the minimum hourly wage in North Carolina.**
